Warm Greetings to the Washington Waldorf School community!

This has been a year of much excitement and transition.

It has been an honor to lead our TC this past year as we have taken on so much as a school and continue to thrive as a Waldorf institution, grow as a community, and demonstrate resilience.

Gym

This year, we saw the power of our community to realize our vision in sharp relief with the John and Mary Brauer Gym now standing on our campus. The time we spent on the Stacey Kornegay bleachers watching our basketball teams compete—having our own space to be a community to cheer on our classmates, children, and friends has been thrilling. The additional space has provided our school with a true landmark that students and faculty use constantly, expanding the day-to-day experience and increasing our potential as a school to offer programming and be a fully realized school experience for all future students and families. I want to thank everyone for making this happen, with a special thanks to our departing Head of School, Lelia True, who worked tirelessly to realize this dream, and to Brad Clark for his vision and generosity, without whom this would not have been possible.

Head of School Transition

With Lelia's departure comes the beginning of a new chapter for our school leadership. Lelia has been with the school for more than 13 years, watching her son, William, grow as a student and graduate and working as a part of the faculty for the past seven years and as Head of School for the past three years. She is a true Red-Tailed Hawk, through and through. Her leadership during COVID and afterward has kept our school moving forward—I truly appreciate all that she

has done for us. As she takes her last bow at the school, we will miss her, but we are also excited to welcome Margery Bank as our new head of school. Our work as a TC in heading up the search led us to a strong pool of well-qualified candidates, and Margery stood out amongst them for her calm, thoughtfulness, and ability to communicate. Her tenure at WWS begins with much to look forward to and a strong foundation. We are excited to support her over the coming months and beyond.

Participation in One Fund

Our focus on development this year has been inspiring—we have seen participation in our One Fund increase massively with over 81% of families participating, 100% of TC members, 100% of College members, and 92% of faculty providing gifts to the school. On top of strong participation, we have surpassed our fundraising goal and have a strong infrastructure within our development office to continue to see success. The One Fund provides the school with the necessary operational support to keep our tuition low (relative to peer schools), support faculty compensation increases to be competitive and pay a living wage, and be able to offer substantial financial aid—some of the most generous in the region. Ensuring that we have broad participation, not just focusing on the dollars we raise, is critical for our community. I hope we can exceed this incredible participation number again next year!

Ongoing focus on strategic plan and mission

Lastly, I want to highlight our continued focus on executing our strategic plan. This plan, created last school year, highlights four pillars of focus for our school—Academic Development & Excellence; Diversity, Equity, Inclusion & Belonging; Organizational & Community Engagement; and Financial Sustainability. Much of what I've highlighted has focused on our work in the first, third, and fourth pillars. For the second pillar, I am extremely proud of the work we have done establishing the DEIB committee this winter, a group focused on reviewing and executing the recommendations provided in the DEIB audit conducted last year. This work has been spearheaded by dedicated College members, TC members, and parents. As that work continues to take shape, the committee will provide constant attention and focus on how we can be a more welcoming and inclusive community that fosters a sense of belonging and pursues equity in our policies and decisions.

A lot has happened over the past year, and even more is on the horizon. The TC is eager to move forward and, as always, we welcome everyone to join our meetings to stay informed and engaged as the school year progresses.

MESSAGE FROM THE BUSINESS MANAGER

The 2023–2024 school year was full of exciting projects. As the Business Office, we have a central role in supporting the school initiatives throughout the year. This report provides an overview of key developments and projects that have shaped the past academic year. Please note that these numbers reflect an unaudited report. A complete audited report will be made available, and financial statements will be made available upon request.

Key Projects and Initiatives

Financial Assistance

Continuing with our commitment to provide access to quality education for all students regardless of their financial circumstances, we increased the financial aid budget by about 30% from the previous year, resulting in an average award of \$17,200. 38% of our students received financial aid in the past year.

Student Support Programs

We maintained clubs in our high school, in addition to the after-school program for Children's Garden through Grade 6, bus transportation from Acorn Hill, and summer camps. These programs have been instrumental in enhancing the educational experience of our students. These initiatives have played a vital role in fostering the holistic development of our school community.

Revenue Diversification

Our money market accounts during the past year has generated nearly 50% of our other income, an increase of 50% from the previous year. We have engaged a financial advisor—Merrill Lynch, to streamline our financial goals and diversification strategy.

Cash Position

Our cash position significantly decreased due to the capital expense of the recently completed gym in the past year.

Faculty Salaries and Benefits

In the past year, we increased faculty salaries by 3%, as we strive to align our compensation packages with local market.

Challenges and Operational Results

While we celebrate our achievements in many areas, we also acknowledge risks to our overall financial statement position attributable to economic and inflationary pressures. We commit to a continual a review of existing and potential revenue streams to enable WWS to offer enhanced programs and continue to improve salaries and benefits for faculty. Additionally, to avoid increasing tuition substantially for all families, we need to ensure that we have a successful enrollment season and continue to meet our fundraising goals each year.

Conclusion

The 2023–2024 school year was yet another successful year within our school administration. We remain dedicated to transparency and responsible financial stewardship as we look ahead to the future. We extend heartfelt appreciation to all staff, past and present, for their contributions and dedication. We look forward to the exciting developments that await us in the coming academic year.





Dear Friends,

The 2023–2024 school year was bookmarked with two events that showcase one of the best attributes of Washington Waldorf School—our community. We began the year with a community picnic and Gym opening, and ended the year with a Faculty Farewell celebration. Throughout the year, the sense of our community was amplified within the walls of our new John and Mary Brauer Gym. Memories were made there this year through the Rose Ceremonies, festivals, and community events.

The theme of the 2023–2024 One Fund was "One Community, Building Together". Each initiative and event we hosted this school year was carried with that sentiment.

Our goals this year were as follows:

Celebrate the Room to Move campaign and John and Mary Brauer Gym

We hosted three events in the Fall of 2023 to commemorate this campaign and monumental achievement for our School. The School year began with a Gym Opening and Welcome Back Community Picnic, precluded by a reception for lead campaign donors. We celebrated the first home basketball game on December 1, 2023, and welcomed alum families, current families, and donors.

Ensure all Room to Move pledges were collected on time, and raise an increased goal for the One Fund

We continued to collect Room to Move pledges, and raised an impressive \$444,444 from 330 donors to the One Fund. The One Fund total is composed from Bazaar proceeds, Annual Fund, and Gala fundraising initiatives.

Increase participation rates amongst Current Parents and Faculty. Stated goals were to reach 75% participation amongst Current Parents, and 80% participation amongst Faculty

The power of our community came through in our 2023/2024 participation rates. We achieved a Current Parent participation rate of 81% and a Faculty participation rate of 92%. The enthusiasm and support during our "Vote

for Washington Waldorf School" participation week was critical to this success.

Increase alum participation and engagement

Quarterly e-newsletters to the Alum Community were continued. We celebrated our first home Alum Basketball game in late December at the John and Mary Brauer Gym. On June 1, the very first Alum Reunion brought back over 40 alums from a wide range of graduating years. This reunion was initiated by the Class of 2004, in celebration of their 20th class reunion.

Identify new grant opportunities

We were pleased to receive a \$5,000 grant this year from the Michael Foundation, specifically to provide professional development and Waldorf teacher training for Faculty members who identify as persons of color.

In the year to come, the Development Office intends to continue building upon and growing in each of the areas above. We accomplished a lot, and there is more to do. The success we achieved this year belongs to our entire school community.

I want to thank a few groups for all the work, time, and effort they put in towards supporting our School in achieving the above goals. The Trustees Council members, chaired by James Wise, were a collective partner in achieving each of our goals. The Trustees Council was the first body of our School to reach 100% giving participation. This leadership set the tone for the rest of the community. Each individual member of the Trustees Council Development Committee, chaired by Kate Mueller, was equally

critical in our success. The Development
Committee's collective efforts raised \$123,456
towards the One Fund last year. The Parent
Leadership Group worked tirelessly last year to
build and support our community, both in
individual classrooms and collectively within
our school community—piloting a lunch program
that served our students throughout the second
half of the year. And lastly, I am grateful to both
the Teaching and Admin Faculty—for showing
up each day and delivering the mission of our
School within and outside the classrooms.
The Development Office would not be able
to achieve our goals without any of the
above groups.

The heart of our School is centered around the relationship between Faculty, Parents, and Trustees. Our school rises to its best and highest capacities when these three bodies work in partnership and collaboration with each other. Congratulations to our entire community on a successful 2023-2024 school year, and I can't wait to see what milestones we will achieve, together, in 2024-2025.

FACULTY PROFESSIONAL DEVELOPMENT FUND FOR FACULTY MEMBERS OF COLOR

This restricted fund comes in response to the recent DEIB Audit completed by Alma Partners, with a final report including commendations and recommendations. It is also intended to address a letter sent by some members of the WWS parent community to the hiring faculty, College, and Trustees Council, highlighting concerns about representation of people of color amongst the current faculty.

Washington Waldorf School has always aimed to provide mentoring and teaching opportunities to prospective faculty members who have an interest in furthering their career in Waldorf education.

The purpose of this additional restricted fund is to provide Waldorf teacher training to faculty members who identify as people of color. This fund creates professional pathways for individuals of color to achieve their goals within the Waldorf movement, thus increasing diversity within the faculty body, to the benefit of the entire community. This fund is intended to be a loan to the recipient(s), forgiven after three years of employment at Washington Waldorf School.

In the summer of 2024, Washington Waldorf School spent a portion of funds raised to date on one Faculty member to attend their first of three years of Waldorf Teacher Education training.







EXCERPT FROM ILIANA'S SPEECH

"Coming back here and speaking in this gym is incredibly emotional. I cannot imagine how wonderful it would have felt to have home games and the ability to practice right after school. The gift that this gym has given the students of this school is unmatched. This is where community happens. This is where we come together.

I would like to add that throughout my Waldorf years, my sister and I could not have attended WWS without financial assistance. My mother was a single parent working to support her two daughters. She knew the incredible gifts that Waldorf education brings to children, and she made it a priority to provide us with that education. However, if we had not received support from the school, that dream would not have been possible. Even though I knew that my sister and I received financial assistance to attend the school, I was never made to feel less worthy to be here. I was treated with the same kindness and warmth that every student receives upon entering this building. My teachers cared about my education and my well-being. ...

The Washington Waldorf School is a special place. I know you all know this as you are here tonight to support the school, but I want to honor and thank the community that supported me, pushed me to be the best I could be, and carried me into my adult life prepared with the skills and knowledge to take on the world."


is a licensed professional counselor in private practice in Portland, OR.
