Pt I Line 2: Pt I Line 2: The Washington Waldorf Schools financial aid program is designed to provide qualified students with an opportunity for a Waldorf education that might otherwise be unobtainable for them due to financial constraints. The Washington Waldorf School subscribes to the principles and services of School and Student Service for Financial Aid (SSS), which provide us, at the request of parents, a financial analysis based on the confidential statements of need. SSS reports provide a framework and point of departure for the decisions made by the Financial Aid Committee. A financial aid budget equal to approximately 19 - 21% of our annual operating budget, funds financial aid of up to 90% of tuition in some instances. In addition, a limited number of high school scholarships are available. Our attempt is to meet each familys demonstrated need as nearly as we can within the constraints of our budget. Although financial need is the first requirement for aid, we make choices that balance the financial needs of the family with the needs and goals of the school
